Project update from British Land

Earlier this year over 2000 people attended the Draft Masterplan exhibitions to see the emerging Canada Water Masterplan and share feedback.

We're reviewing the masterplan, and the proposals will evolve from those shared in February. We're currently targeting a planning application in 2017 and there will be further consultation as plans develop, including topic discussions on the areas of most interest.

Leisure Centre update: At a public meeting on the 28th June the preferred location for a new leisure centre was discussed. It was agreed that the Council and British Land will, as part of the ongoing review of the masterplan, work to identify other potential opportunities and locations for a new leisure centre at Canada Water.
