## Context

Inclusion of Surrey Quays Shopping Centre is a significant change to the project. British Land are re-thinking the approach to the full shopping centre site (including the shopping centre, service yard, car park and frontage onto Canada Water) to understand how this can work best with the Printworks site and the surrounding developments.

Southwark Council's Area Action Plan envisages significant growth and change in the area, and as part of this, the two sites will form part of an emerging town centre in the Canada Water / Surrey Quays area. To support this it is anticipated that there will be additional development and a range of uses on the site.




